IQS Master's Academic Excellence Scholarship

For students who are beginning their master's studies, this **scholarship** covers **up to 40% of the tuition**, for the best undergraduate academic transcripts, depending on the applicant's financial situation. These scholarships can be awarded to students enrolled in any IQS master's programme except for the Master in Global Entrepreneurial Management.

Terms and conditions to apply for scholarships

To apply for **Academic Excellence Scholarship**, you must fill out the required information on the following link, www.iqs.edu/en/scholarships, before the deadlines.

- a. **Official academic transcript** with the grades obtained in your undergraduate degree. Students who have studied at foreign schools must access the following link: www.universidades.gob.es to calculate the corresponding equivalency and submit the certificate they obtain.
- b. **Letter of motivation** expressing the reasons why you are applying for the scholarship.
- c. European **Currículum Vitae** format. You can find the template [here](#).
- d. Complete, fully legible photocopy of your **family's tax return** from the preceding financial year on which the bank or electronic filing code is present. For individual tax returns, you must submit a copy of your mother and father's returns or a certificate stating there was no obligation to file a return.
- e. Photocopy of both your mother and your father's last **payslip** or a photocopy of the last invoice payment received for self-employed individuals.
- f. **Cohabitation certificate** attesting the people who live in the same residence as the applicant.

Master's Financial Aid Scholarship

For students with financial need. These scholarships are based primarily on your family's income level and satisfactory academic performance. **Scholarships for up to 40% of tuition are awarded.**

Terms and conditions to apply for scholarships

To apply for a **Financial Aid Scholarship**, you must fill out the required information on the following link, www.iqs.edu/en/scholarships, before the deadlines.

- a. Official **academic transcript** with the grades obtained in your undergraduate degree.
- b. **Letter of intent** indicating the programme you wish to study or are studying, addressed to the President of the Scholarship Committee, in which the applicant's father, mother, or guardian state the reasons justifying the scholarship application, the family's situation and personal circumstances, as well as any additional information deemed necessary.
- c. Documentation corresponding to the **online submission of tax returns** for the previous fiscal year. For individual tax returns, you must submit a copy of your mother and father's returns or a certificate stating there was no obligation to file a return.
- d. Photocopy of both your mother and your father's last **payslip** or a photocopy of the last invoice payment received for self-employed individuals.
- e. European **Currículum Vitae** format. You can find the template [here](#).
- f. **Cohabitation certificate** attesting the people who live in the same residence as the applicant.

The evaluation criteria for the IQS Master's Financial Aid Scholarship are:

- a. Having completed the pre-registration process for an IQS master's degree programme.
- b. Not exceeding €17,000 per year on the personal income tax return per family member in the household.

- a. **Official academic transcripts** with the grades obtained in your undergraduate degree.

All scholarship applications from international students will be assessed individually.



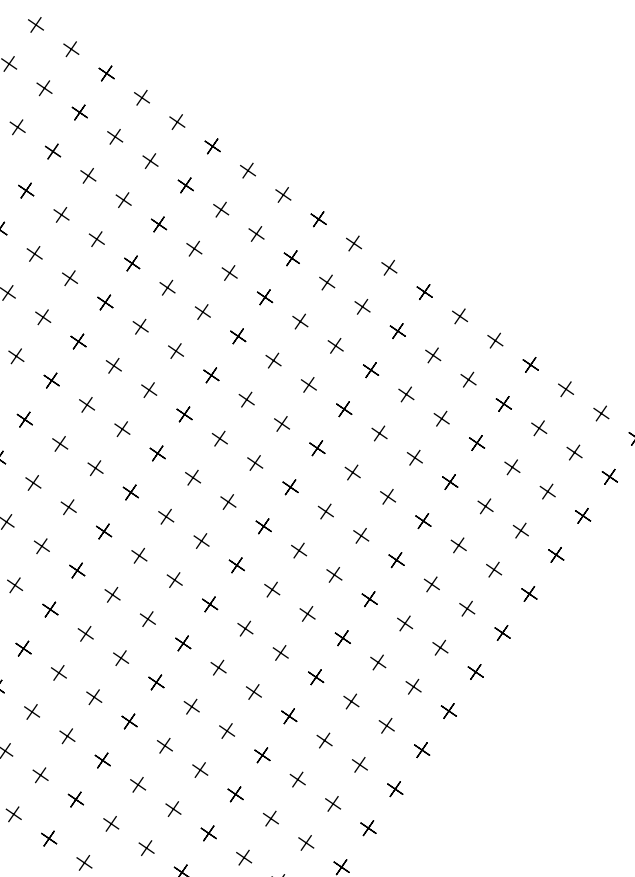

Special grants for academic year 2024-2025

For academic year 2024-2025, special grants have been allocated for all students who enrol in the Master's Degree in Materials Science and Engineering and the Master's Degree in Analytical Chemistry. The grants will be applied automatically.

Master's Degree Sustainability Scholarship

A **grant for 30% of tuition fees** will be awarded to all applicants to the Master's Degree in Materials Science and Engineering.

Jaroslav Heyrovský Master's Degree Scholarship

To honour the 100th anniversary of the invention of the chemical analysis method called polarography, a scholarship **for 30% of tuition** is being awarded to all applicants to the Master's Degree in Analytical Chemistry.

GRANT FOR 30% OF FIRST YEAR TUITION FEES

For academic year 2024-2025, certain Academic Excellence Scholarships have been established for students with an entrepreneurial spirit who wish to apply to the Master in Global Entrepreneurial Management.

Entrepreneurship Scholarship

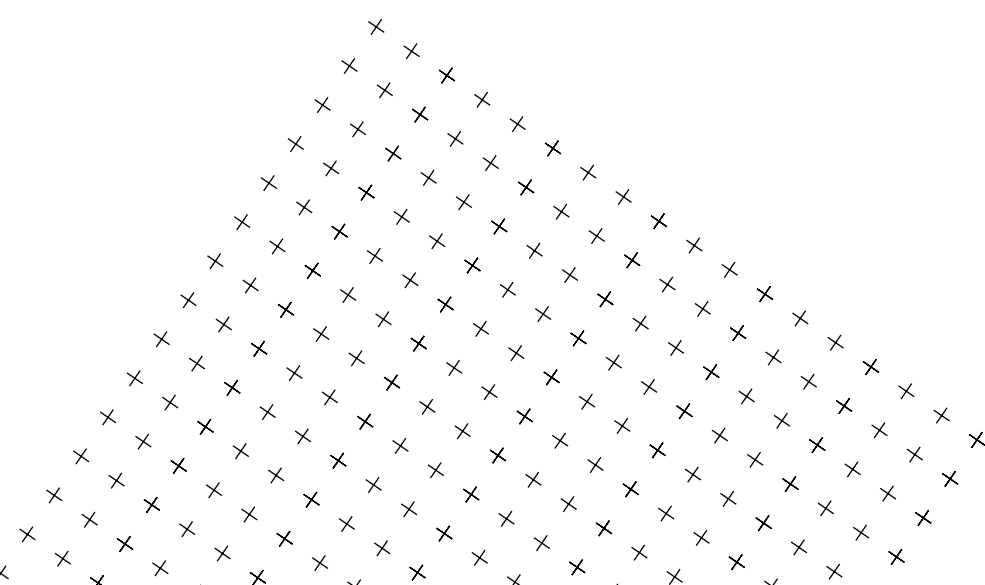

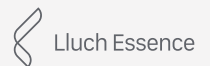
