



# Scholarships, grants, and financing

## IQS Undergraduate Academic Excellence Scholarship

This scholarship is awarded to incoming undergraduate students of Spain and Andorra with the best academic records, up to a maximum amount equivalent to 30 credits (maximum scholarship of 50%). Students with the best academic records will be awarded the scholarship, starting from 8.5 points and above out of 10, which is the weighted mark between the Baccalaureate results and the PAU exams (University Access Exams). In addition, the family financial resources of each applicant will be taken into account when awarding the scholarships. To apply via the international baccalaureate route, the minimum grade point average must be 9 out of 10.

# IQS Undergraduate Academic Excellence Scholarship

## Terms and conditions to apply

### SCHOLARSHIP FOR UP TO 50% OF TUITION

To apply for an **IQS Undergraduate Academic Excellence Scholarship** you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the deadlines.

- a. Complete **academic transcripts** of the grades earned in your Baccalaureate or equivalent studies.
- b. **Certificate** of your PAU results or UNED (National Distance Education University) accreditation from the June 2024 exam session. The **PAU qualification** with the university access grade must be submitted as soon as it is published.
- c. Documentation corresponding to the **online submission of tax returns** for the previous fiscal year. For individual tax returns, you must submit a copy of your mother and father's returns or a certificate stating there was no obligation to file a return.
- d. Photocopy of both your mother and your father's last **payslip** or a photocopy of the last invoice payment received for self-employed individuals.
- e. **Cohabitation certificate** attesting the people who live in the same residence as the applicant.

The percentages are applied to the tuition for an academic courseload of 60 ECTS hours based on the price of €223.50/ECTS.



## IQS Undergraduate Financial Aid Scholarship

This scholarship is awarded to students who are residents of Spain or Andorra and have financial need. These scholarships are based primarily on your family's income level and satisfactory academic performance.

For the Degree in Pharmacy, this scholarship is processed through the Blanquerna Economic Aid Service.

### Terms and conditions to apply

#### SCHOLARSHIP FOR UP TO 75% OF TUITION

To apply for an **IQS Undergraduate Financial Aid Scholarship**, you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the deadlines.

- a. Complete **academic transcripts** of the grades earned in your Baccalaureate or equivalent studies.
- b. **Certificate** of your PAU results or UNED (National Distance Education University) accreditation. The PAU qualifications with the university access grade must be submitted no later than 2 July.
- c. **Letter of intent** indicating the programme you wish to study or are studying, addressed to the President of the Scholarship Committee. The applicant's father, mother, or guardian must state the reasons justifying the application for the scholarship, the family's situation, personal circumstances, as well as any additional information deemed necessary.
- d. Documentation corresponding to the **online submission of tax returns** for the previous fiscal year. For individual tax returns, you must submit a copy of your mother and father's returns or a certificate stating there was no obligation to file a return.
- e. Photocopy of both your mother and your father's last **payslip** or a photocopy of the last invoice payment received for self-employed individuals.
- f. **Cohabitation certificate** attesting the people who live in the same residence as the applicant.

**The evaluation criteria for the IQS Undergraduate Financial Aid Scholarship are:**

- a. Having completed the pre-registration process for an IQS undergraduate programme.
- b. Not exceeding €17,000 per year on the personal income tax return per family member in the household.

## IQS Full Tuition Scholarship

100% scholarship fully covering the cost of tuition intended for students with the best academic records and highly-limited financial resources. To be accepted for this scholarship, students must have earned 8.5 points or above out of 10 on their access score, which is the weighted mark between the Baccalaureate results and the PAU exams (University Access Exams).

In addition, the scholarship includes further support of €3,000 during the first year to help with expenses for living, transport, materials, and so on.

This scholarship is aimed at Spanish nationals who reside in Spain.

To apply for an **IQS Full Tuition Scholarship**, you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the deadlines.

- a. Complete **academic transcripts** of the grades earned in your Baccalaureate or equivalent studies.
- b. **Certificate** of your PAU results or UNED (National Distance Education University) accreditation. The **PAU qualifications** with the university access grade must be submitted no later than 2 July.
- c. **Letter of intent** indicating the programme you wish to study or are studying, addressed to the President of the Scholarship Committee. - b. Not exceeding € 15,000 per year on the personal income tax return per family member in the household.

### Terms and conditions to apply

#### SCHOLARSHIP FOR UP TO 40% OF TUITION

To apply for an **IQS Undergraduate International Student Scholarship**, you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the deadlines.

- Complete **academic transcripts** of the grades obtained in your last two years of pre-university studies.
- Letter of intent** indicating the programme you wish to study or are studying, addressed to the President of the Scholarship Committee. The applicant's father, mother, or guardian must state the reasons justifying the application for the scholarship, the family's situation, personal circumstances, as well as any additional information deemed necessary.
- Documentation certifying the family's total income level and residence outside of Spain.

### Deadlines for sending documentation

#### 21 June 2024

All scholarship applications from international students will be assessed individually.

## Discounts and Scholarships:

IQS offers discounts to students who meet the following requirements. These discounts cannot be combined together and are only valid for students who meet the special conditions indicated below and can provide proof upon enrolment. These discounts are not applicable for the Bachelor's Degree in Pharmacy.

### Large family:

Students with a large or single parent family. Discount of 5% of the tuition fees as long as this status is accredited. Renewal is automatic as long as the large family card remains valid at the time enrolment is done.

### Second sibling at IQS:

For students with a sibling who is studying a bachelor's or master's degree at IQS. A 5% discount is applicable for the second sibling as long as the first sibling is studying at IQS. For twins in the same academic year, the discount applies to both students.

### Tourism Reactivation Scholarship:

Spanish students of the Bachelor's Degree in Tourism and Hospitality Management can take advantage of the Tourism Reactivation Scholarship, representing a €3,000 discount from total tuition fees. This scholarship cannot be combined with other scholarships or discounts.

## **Renewals**

IQS scholarships are automatically renewed if students meet the minimum requirements: for the IQS Undergraduate Academic Excellence Scholarship, students must earn an average grade in each course in the first term equal to or greater than 8.0, weighted by the number of credits. If this is not achieved, the proportional part is granted to the credits earned provided that the weighted grade average is equal to or greater than 7.0. To renew an IQS Undergraduate Financial Aid Scholarship, IQS Full Tuition Scholarship or the IQS Undergraduate International Student Scholarship, you must submit the required information on the following link, [www.iqs.url.edu/scholarships](http://www.iqs.url.edu/scholarships), apply for renewal within the established deadlines and: (I) not have withdrawn from any of the subjects during the year; (II) not fail any more than 20% of the credits taken in the second exam session; and (III) maintain a level of family income similar to what was reported when the initial scholarship was awarded.

For the IQS Full Tuition Scholarship, maintaining suitable academic performance is also required.

## **Financing arrangements**

Students and their families can apply for a bank loan for the full or partial payment of tuition through the agreements IQS has in place with different financial institutions.
