# Academic Excellence Scholarship

This scholarship is awarded to incoming undergraduate students from Spain and Andorra with the best academic records (maximum scholarship of 50%). Students with the best academic records will be awarded the scholarship, starting from 8.5 points and above out of 10, which is the weighted mark between the Baccalaureate results and the PAU results from the last regular call for exams. (University Access Exams). To apply via the international baccalaureate route, the minimum grade point average must be 9 out of 10. In addition, the family financial resources of each applicant will be taken into account when awarding the scholarships.

Within the framework of the IQS Undergraduate Academic Excellence Scholarship, the following will also be awarded:  **STEM Scholarship for engineering students:** This scholarship aims at supporting the education of women who wish to apply to the Undergraduate Programme in Industrial Engineering and the Undergraduate Programme in Chemical Engineering.

## Terms and conditions to apply

### Scholarship for up to 50% of tuition

To apply for an **IQS Undergraduate Academic Excellence Scholarship** you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the indicated deadlines.

- a. Complete **academic transcripts** of the grades earned in your Baccalaureate or equivalent studies.
- b. **Certificate** of your PAU results or UNED (National Distance Education University) accreditation from the current year. The **PAU qualification** with the university access grade must be submitted as soon as it is published.
- c. **Cohabitation certificate** of the individuals living in the same household as the applicant, with a maximum date of six months.
- d. Document corresponding to the **electronic filing of the tax return** for the last financial year. In case of an individual tax return, a copy of the tax returns of both parents must be submitted. In case of separation or divorce and, with guardianship and shared custody by the spouses, the income tax returns of both parents must be submitted.
- e. If you do not have to file your income tax return, you must provide: a) Certificate that you do not have to file your income tax return. b) Work history certificate. c) Income and withholding statement of all members of the active family unit.
- f. **Employee documentation:** Copy of the last **pay stub** of the parents and relatives (siblings, partner, etc.) who work and live with the student.
- g. **Entrepreneur and self-employed individuals documentation:** Entrepreneurs or self-employed individuals must enclose

a document accrediting the results of their work (corporate taxes or income tax on economic activities from the last year, the last four quarterly VAT statements, the annual VAT statement, etc.), and the investee companies.

- h. **Separation or divorce ruling and governing agreement**, if necessary.

# Financial Aid Scholarship

This scholarship is awarded to students who are residents of Spain or Andorra and have financial need. These scholarships are based primarily on your family's income level and satisfactory academic performance. For the Degree in Pharmacy, this scholarship is processed through the **Blanquerna** Economic Aid Service.

## Terms and conditions to apply

### Scholarship for up to 75 % of tuition

To apply for an **IQS Undergraduate Financial Aid Scholarship**, you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the indicated deadlines.

- a. Complete **academic certification** of the grades obtained in secondary school baccalaureate or equivalent studies.
- b. **Certificate** of the University Access Exam (PAU) results or UNED accreditation. The **PAU grade** with the university access grade must be sent as soon as it is published.
- c. **Letter of intent** indicating the degree you wish to study or are studying, addressed to the President of the Scholarship Committee. The applicant's parents or guardian must state the reasons justifying the scholarship application, the family's situation and personal circumstances, as well as any additional information deemed necessary.
- d. **Cohabitation certificate** of the individuals living in the same household as the applicant, with a maximum date of 6 months.
- e. Document corresponding to the **electronic filing of the tax return** for the last financial year. In case of an individual tax return, a copy of the tax returns of both parents must be submitted. In case of separation or divorce and, with guardianship and shared custody by the spouses, the income tax returns of both parents must be submitted.

**The guiding criteria for the assessment of the IQS Undergraduate Financial Aid Scholarship are:**

- a. Having completed the pre-registration process for an IQS bachelor's degree.
- b. The sum of the amounts of the tax bases of the income of the reporting members, divided by the number of members of the household, must be less than €20,000 per member of the household.

# IQS Full Tuition Scholarship

100% scholarship fully covering the cost of tuition intended for students with the best academic records and highly-limited financial resources. To be accepted for this scholarship, students must have earned 8.5 points or above out of 10 on their access score, which is the weighted mark between the Baccalaureate results and the PAU exams (University Access Exams). In addition, the scholarship includes further support of **€3,000** during the first year to help with expenses for living, transport, materials, and so on. This scholarship is aimed at Spanish nationals who reside in Spain.

# International Student Scholarship

This scholarship is awarded to students who reside outside of Spain, have financial need, and have excellent academic performance.

## Terms and conditions to apply

### Scholarship for up to 40 % of tuition

To apply for an **IQS Undergraduate International Student Scholarship**, you must fill out the required information on the following link, [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships), before the deadlines.

- a. Complete **academic transcripts** of the grades obtained in your last two years of pre-university studies.
- b. **Letter of intent** indicating the programme you wish to study or are studying, addressed to the President of the Scholarship Committee. The applicant's parents or guardians must state the reasons justifying the application for the scholarship, the family's situation, personal circumstances, as well as any additional information deemed necessary.
- c. Documentation certifying the family's total income level and residence outside of Spain.

## Discounts and Scholarships:

IQS offers discounts to students who meet the following requirements.

### Large or single parent family:

Students with a large or single parent family, as applicable. Discount of 5% of the tuition fees as long as this status is accredited.

### Second sibling enrolled at IQS:

For students with a sibling who is studying a bachelor's or master's degree at IQS. A 5% discount is applicable for the second sibling as long as the first sibling is studying at IQS. For twins in the same academic year, the discount applies to both students.

### Alumni Premium IQS:

5% tuition discount if the student can prove that their parent, grandparent, or legal guardian holds IQS Alumni Premium status. This discount does not apply to the Bachelor's Degree in Pharmacy.

**Important:** The "large or single-parent family discount" and "sibling at IQS discount" cannot be combined.

## Renewals

Renewal of the scholarship must be applied for every academic year before the deadline listed on this page.

Maintaining an IQS scholarship is guaranteed if the student meets the minimum requirements:

**In the case of the IQS Undergraduate Academic Excellence Scholarship:**

- It will be necessary to fill out the economic information requested at the following link: [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships)
- Make the renewal request within the established deadlines.
- It is required to earn a grade point average for each course in the first term, weighted by the number of credits, equal to or greater than 8.0. If this is not achieved, the proportional part is granted to the credits earned provided that the weighted grade average is equal to or greater than 7.0.

**In the case of the IQS Undergraduate Financial Aid Scholarship, IQS Full Tuition Scholarship and IQS Undergraduate International Student Scholarship:**

- It is required to fill in the economic information requested at the following link: [www.iqs.edu/en/scholarships](http://www.iqs.edu/en/scholarships)
- Make the renewal request within the established deadlines.
- The following requirements must be met: (I) Not have withdrawn from any of the subjects in the academic year; (II) Not have failed more than 20% of the credits taken in the second exam session; (III) Have a family income level similar to what was reported at the time of the initial scholarship awarding.
- For the IQS Full Tuition Scholarship, adequate academic performance is also required.

## Financing arrangements

Students and their families can apply for a bank loan for the full or partial payment of tuition through the agreements IQS has in place with different financial institutions.
